36-month Fibre1000 contract

Minimum charge is based on a 36-month contract. Offer is only available in limited TPG on-net buildings. Customer address must be pre-qualified before a formal quotation can be provided. Installation times depend on site/building access. Check [https://www.tpg.com.au/nbn/nbn-rollout] for coverage and for updates when NBN coverage will be available in your area.

Early termination charges

All NBN plans have a Minimum Contract Period. The Minimum Contract Period is the minimum period during which you must acquire the service. The

Minimum Contract Period begins when the service is activated. If you cancel your service before the end of your Minimum Contract Period, early termination fees (ETF) will apply. You are required to pay 85% of the remaining contract value. After the Minimum Contract Period, you may terminate the NBN service by giving us at least 30 days' written notice. You must pay charges for the service up to the end of the notice period.

Monthly data allowance

Unlimited. There are no time restrictions and no excess usage charges. Our Acceptable Usage Policy applies.

BizPhone offer

Optional BizPhone offer may be withdrawn without notice and is not available to existing Fibre400, Fibre1000, or BizPhone customers. *Up to 5 standard BizPhones only.
